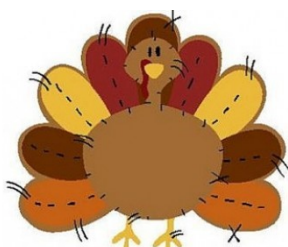

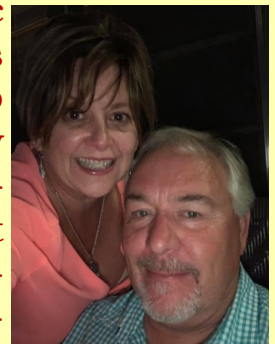
Volunteer of the Year
